I. THE FIRST PART

INTRODUCTORY SPEECH BY THE GENERAL DIRECTOR OF THE CORRECTIONAL SERVICE



I have the honor and pleasure, in the context of transparency with the public, to present the annual work report of the Kosovo Correctional Service for 2024.

This report provides detailed data on the activities and work activities of the Kosovo Correctional Service for one (1) year.

The data presented in this report reflects our maximum commitment to fulfilling our obligations as well as the identification of certain areas where our capacities need to be increased in order to increase the performance of KCS employees.

During 2024, the KCS has been committed to building the professional capacities of officers through various professional trainings, study visits, seminars, workshops, etc. In order to build human capacities, the KCS has recruited 114 correctional officers during this period and is in the process

of recruiting another 80 correctional officers.

Through various activities and programs, the KCS, in addition to protecting the rights of prisoners, has contributed to the rehabilitation and resocialization of persons who have violated the law for successful reintegration into society.

MISSION

The mission of the Kosovo Correctional Service is to ensure the presence and well-being of persons deprived of their liberty, who are held in Correctional Institutions, to correct and resocialize prisoners while respecting their fundamental rights, without discrimination, and to prepare them for a life in freedom as useful persons for the society in general.

VISION

To promote a fair and secure society through the efficient and effective management of offenders and the administration of justice.

STATUS

The KCS is an Executive Security Agency that operates within the Ministry of Justice and has its own identification mark, uniform, flag and emblem.

SCOPE OF WORK UNDER THE LAW

- Organization, implementation and supervision of the execution of imprisonment sentences in accordance with the legislation in force;
- Organization, implementation and supervision of juvenile detention and educational measures in CI, unless the Juvenile Justice Code provides otherwise;
- · Implementation of the measure of detention under the Criminal Procedure Code;
- Taking security measures to provide a safe and suitable environment for living and working;
- Taking actions to maintain order, discipline and property protection in the correctional institutions of the KCS;
- · Assessment of risk and treatment needs of prisoners;
- · Planning, organizing, implementing and supervising programs that contribute to the resocialization of prisoners;
- · Encouraging, motivating and developing working skills and abilities for prisoners;
- Development of economic activity and generation of income through the KCS economic unit;
- · Motivating and creating opportunities for education and professional training for prisoners;
- Professional development of KCS staff;
- Establishing cooperation with relevant institutions and organizations dealing with the issue of monitoring prisoners' rights;
- · Guidance and support to convicted persons regarding the new post-release integration plan;
- · Fulfillment of other obligations under applicable legislation.

II. THE SECOND PART

Overview

The Kosovo Correctional Service has fulfilled its obligations with professionalism and integrity, based on the Law on the Execution of Criminal Sanctions, the Law on the Kosovo Correctional Service, sub-legal acts, internal rules, other applicable legislation, international standards, as well as the priorities of the Kosovo Correctional Service's work plan. During this period, the Kosovo Correctional Service has carried out a series of activities within its scope and, according to assessments, has made progress in achieving its work objectives, while maintaining transparency in the way it exercises its functions and responsibilities towards inmates, staff, and society.

With its human resources capacity, the Kosovo Correctional Service has been fully committed to fulfilling its mission for the resocialization of individuals who have violated the law, ensuring the legality of its work, improving the quality of treatment, respecting human dignity and the fundamental rights of persons deprived of liberty, continuously improving living and accommodation conditions, within budgetary constraints and with support from donors as strategic partners of the Kosovo Correctional Service.

The General Director has represented the Kosovo Correctional Service in all domestic and international processes. The Deputy General Directors, the General Directorate, and the Correctional Institutions, within their responsibilities, have carried out various activities to achieve the objectives set for 2024.

Transparency

In line with the principles of transparency and accountability, the Kosovo Correctional Service (KCS) has continued its commitment to raising standards for public information, strengthening cooperation with the public, and building sustainable communication with both electronic and print media.

Transparency, as one of the main pillars of the KCS's work, not only represents an obligation to provide accurate information but also guarantees free and easy access for all interested parties to information related to our work and activities.

During 2024, the Media Division has carried out a number of activities to fulfill this mission:

- Response to media requests: A total of 90 media requests for information have been processed and responded to.
- Access to public documents: 10 requests for access to public documents were received, of which 9 were approved, and 1 was rejected, in accordance with the applicable legislation.
- Television stories: 20 television stories were produced in correctional institutions, showcasing the work, achievements, and challenges of these institutions.
- Press releases: 175 official press releases were prepared and published, regularly distributed through the KCS website and social media channels.
- Documentary for the 25th anniversary of KCS: To mark the 25th anniversary of its founding, the KCS produced and published a documentary reflecting the history, development, and achievements of the Kosovo Correctional Service.

Through these activities, the Kosovo Correctional Service has demonstrated its commitment to being a transparent, trustworthy, and approachable institution for the public and the media. We remain dedicated to continuing to improve communication and increase cooperation with all stakeholders in the coming years.

III. THE THIRD PART

Legal Matters

The Kosovo Correctional Service, through its Legal Department, has ensured the legality of the work of correctional institutions so that every activity and decision-making process is in accordance with the law. During this period, the Correctional Service has managed to meet the legal needs of its scope of operations, eliminating legal difficulties and gaps for efficient functioning and enabling the realization of the rights of persons deprived of liberty who are held in correctional institutions.

Based on the work plan of the Legal Department of the Kosovo Correctional Service and the Ministry of Justice's Work Plan for 2024, actions have been taken to fulfill obligations and carry out duties with responsibility. The Legal Department has provided the necessary legal support for the efficient operation of the KCS, and in this annual report, the achievements are presented.

Obligations for drafting sub-legal acts for the implementation of the Law on the Kosovo Correctional Service and the Law on the Execution of Criminal Sanctions: The Legal Department has planned and undertaken all necessary actions to draft administrative instructions to complete the secondary legislation.

In 2024, the following sub-legal acts were approved:

Visits to Correctional Institutions Related to the Supervision of Legislation Implementation:

During the year, visits were conducted to correctional institutions (Mitrovica Detention Center, Smrekonica Correctional Center, High-Security Prison, Pristina Detention Center, Juvenile Correctional Center, and Women's Correctional Center in Lipjan) regarding the supervision of the implementation of legislation. Reports with findings and corresponding recommendations were prepared.

Regular supervision and recommendations for improvement have positively impacted ensuring that actions are in compliance with the applicable legislation and have contributed to enhancing the efficiency of the operations of correctional institutions. Additionally, monitoring was carried out through various correspondence and reports prepared by the correctional institutions.

Visit of the Committee on Legislation, Mandates, and Immunities to the General Directorate:



The General Director of the Kosovo Correctional Service, Mr. Ismail Dibrani, met with members of the Committee on Legislation, Mandates, and Immunities, with whom they discussed the implementation of the Law on the Execution of Penal Sanctions, rehabilitation programs, treatment, and general conditions within correctional institutions.

Requests for Pardon:

In 2024, 105 requests for pardon from prisoners were received and forwarded to the competent authorities. The Legal Department reviewed and completed the documentation according to the prisoners' requests for pardon, ensuring and facilitating the prisoners' access to address their requests to the Presidency for the exercise of the right to pardon. However, no decree for pardon has been received from the President of the Republic of Kosovo.

Requests for Suspension of Sentence:

In 2024, 11 requests for suspension of sentences were submitted due to health conditions. Of these, 4 requests were approved, while one request was rejected by the court.

This information reflects the efforts and procedures surrounding the requests for elemency and suspension of sentences handled by the Kosovo Correctional Service.

Requests for Extradition and Transfer:

During 2024, the Legal Department received and forwarded responses for 9 (nine) requests to the Department for International Legal Cooperation in the Ministry of Justice as follows:

- A request for information from the Swiss federal office regarding the transfer of N.K. from HSP to the Dubrava Correctional Center (response on 11/12/2024);
- 2. A request for information regarding the transfer of prisoner L.M. from Kosovo correctional institutions to the Republic of North Macedonia to serve the remainder of the sentence (response on 05.08.2024);
- A request for information from Swiss authorities regarding the extradition of prisoner P.Gj. to the Republic of Kosovo, as requested by the Gjakova Court via an international arrest warrant (response on 08.06.2024);
- A notification from Swiss authorities regarding the approval of the extradition of prisoner l.E. to Kosovo correctional institutions (01.03.2024);
- A request for information from the Norwegian Embassy regarding guarantees related to the conditions of imprisonment and treatment of prisoners in Kosovo correctional institutions (response on 26.02.2024);
- A request for information from Turkish authorities regarding the extradition of detainee M.K. to Turkish correctional institutions (response on 14.02.2024);
- 7. A request for information regarding prisoner V.K. from the Kingdom of Belgium about the remainder of the sentence in correctional institutions (response on 09.02.2024);
- A request for information from Austrian authorities (judiciary) regarding the duration of imprisonment for prisoner V.S. in Kosovo correctional institutions (response on 12.01.2024);
- A request for information from authorities of North Macedonia regarding the duration of detention for detainee L.M. in Kosovo correctional institutions (response on 09.01.2024).

Legal Support

Within the year 2024, legal recommendations and opinions were provided based on the requests of correctional institutions and the Director General of the Kosovo Correctional Service. The opinions clarified decision-making on various issues and ensured compliance with the applicable legislation.

Response to the Recommendations of the Ombudsperson's Reports

During the year, the Kosovo Correctional Service (KCS) was monitored by legally authorized institutions, particularly by the Ombudsperson. Reports were received from the National Preventive Mechanism (Ombudsperson) for the Juvenile Correctional Center in Lipjan and other correctional institutions. For all reports, responses were provided with recommendations regarding the implementation of measures, with continuous efforts to improve living conditions and the treatment of prisoners in the correctional institutions.

The Ombudsperson's Institution conducted monitoring visits during this year to the Juvenile Correctional Center in Lipjan, the Dubrave Correctional Center, and the Prizren Detention Center.

The Ministry of Justice's Inspectorate carried out 83 regular visits to Correctional Institutions in 2024.

Monitoring was also conducted by the Ministry of Justice's Internal Auditors, the National Audit Office, the International Red Cross, and other mechanisms such as sanitation inspectors and NGOs, based on cooperation agreements.

COOPERATION AGREEMENT

Memorandum of Cooperation with Institutions and Non-Governmental Organizations

- · Memorandum of cooperation between the Kosovo Judicial Council (KJC) and the Kosovo Correctional Service.
- Agreement for the acceptance of a donation provided by the United States of America through the INL program.
- · Memorandum of cooperation between the Kosovo Correctional Service and the Employment Agency.
- Agreement with the Ministry of Justice, the Health and Social Services Institution (KPS), and the Kosovo Correctional Service (KCS) for the integration into the Ministry of Justice's system for prisoners whose offenses are related to domestic violence.

Agreements with Non-Governmental Organizations

For the rehabilitation and reintegration of prisoners and juveniles, the following cooperation agreements have been made:

- Cooperation agreement with the NGO "SIT" continuation of the two-year agreement for the implementation of the "Y+" Psycho-Social Program for juveniles in the Lipjan Correctional Center and the "Y+ Life Skills" program for the adult prisoner group in the Dubrave Correctional Center.
- Cooperation agreement with the NGO "Monumenta" for the project "Art from Prison", where a group of female prisoners (10) were trained in the activity "Filigree on Paper", which was exhibited at the National Library of Kosovo. The artworks were sold at auction, and the proceeds were deposited into the personal accounts of the prisoners.
- Cooperation agreement with the NGO "Mural Fest Kosova" for the mural project at the Lipjan Correctional Center, involving prisoners who learned mural techniques and assisted in painting them.
- Cooperation agreement with the NGO "Islamic Relief" for the development of professional skills and support for individuals in rehabilitation.
- Memorandum of cooperation with Universum College O.P. for the provision of an English language course for prisoners, with particular emphasis on juveniles and women. A total of 11 juveniles and 10 female prisoners were certified upon completion of this 6-week course.
- Cooperation agreement with "Education+" aimed at improving and providing access to education and professional development for prisoners.
- Cooperation agreement with "La Belle Beauty School Academy L.L.C." for the support and empowerment of female prisoners in the Women's Correctional Center in Lipjan, focusing on professional development in the field of hairstyling and beauty, and providing necessary materials such as equipment and products.
- Cooperation agreement with the Institute for Security and Resilience (ISRE) for the implementation of joint research and advocacy projects, as well as for the strengthening of the Kosovo Correctional Service's capacities.

Whistleblowing in the Kosovo Correctional Service

The General Director of the Kosovo Correctional Service, with the aim of raising awareness among individuals held in Correctional Institutions regarding the use of the whistleblowing mechanism, has taken concrete actions to inform them about potential violations of their rights and benefits. They have been encouraged to address any violations to the responsible official for whistleblowing. In addition, the whistleblowing mechanism has been installed in the premises of the Correctional Institutions and has also been personally distributed to each prisoner, with the following text:



WHISTLEBLOWING NOTIFICATION

KOSOVO CORRECTIONAL SERVICE

Dear Siv/Madam

As the Director General of the Kosovo Correctional Service, I would like to inform you that despite the restriction of your freedom of movement due to the sentence being served, the applicable legislation reparding the execution of criminal sanctions recognizes and guarantees a range of rights and benefits during your stay in correctional institutions.

In order to ensure justice and protect your rights during the execution of criminal sanctions. I encourage you to report any legal violations related to the realization of your rights and benefits, as alignfated by the relevant legal provisions. I also suggest that you report any abuse or mistreatment that you may experience during your stay in the correctional institutions, whether it is from staff or other institutes.

I assure you that whistleblowing can be done in a secure and confidential manner. To protect your rights, you may contact the responsible whistleblowing officer, who works within the Kosovo Correctional Service, at the address below or through other designated channels for reporting

Your identity will be protected, and you will not face any consequences for making a lawful and rightful report. Any report made by you will be handled seriously and in accordance with the law by the responsible officer.



Operations Center - Security

During the period from 01.01.2024 to 31.12.2024, a total of 3,710 inmates were admitted to the Correctional Institutions. Among them: 1,335 male convicts (adults), 26 female convicts, 2,156 male detainees (adults), 68 female detainees, 101 juvenile detainees, 2 juvenile female detainees, 4 juvenile convicts, and 18 juveniles with educational measures.

General diagram of prisoners admitted to correctional institutions




^{*} Diagram of prisoner admissions to Correctional Institutions - Year 2024

Prisoner releases:

According to reports from Correctional Institutions, a total of 3630 prisoners were released during 2024. Of these, there were: 1586 male convicts (adults), 29 female convicts (adults), 26 juveniles with educational measures and 1839 male detainees (adults), 62 female adult detainees (adults) and 81 detainees (juveniles), 06 convicts (juveniles), 01 juvenile with educational measures (female).

Statistics on the detection and prevention of contraband in Correctional Institutions

During 2024, 211 raids were recorded in Correctional Institutions, of which 84 (39.81%) were findings of contraband and the other 127 (60.19%) were preventive raids.




Diagram of the detection of contraband (in quantity) in Correctional Institutions during the year 2024



At the Institute of Forensic Psychiatry (IFP) at the University Clinical Center of Kosovo (UCCK), there are currently (11) male prisoners hospitalized for treatment and examination. In the IFP, during the year 2024, 74 psychiatric treatments were carried out, and (32) transfers back to institutions were made.

Table 11. Number of prisoner movements by institution




Diagram of prisoner movements to hospitals/clinics outside Correctional

V. THE FIFTH PART

TREATMENT OF THE PRISONERS

Rehabilitation/Resocialization of Prisoners and Preparation for Reintegration

The Kosovo Correctional Service remains committed to helping prisoners change positively and prepare for reintegration into society, as responsible and useful individuals for society and the environment in which they will live.

According to the Law on the Execution of Criminal Sanctions and the sublegal acts of the Kosovo Correctional Service, correctional institutions ensure the provision of conditions for prisoners to exercise their rights through the development of programs, daily activities within the correctional institution. Within the framework of the Kosovo Correctional Service, there are 11 correctional institutions in which various activities are developed. The mission of the KCS is the resocialization of convicted persons during their sentence and their reintegration into society, therefore the KCS organizes various programs for re-education/re-socialization for successful reintegration after release.

During 2024, despite significant professional challenges, demands and needs, within the framework of our service, especially in the areas of resocialization and reintegration of prisoners, the number of rehabilitation programs for prisoners has increased, which also resulted in the inclusion of a larger number of prisoners.

Cooperation with institutions and non-governmental organizations

- The UPSHIFT / IPKO Foundation project supported by Unicef Kosovo Programme and European Union in Kosovo, trainings have been conducted in:
 - - Tailoring;
 - Printing/stamping;
 - Hairdressing;
 - Wood engraving.
 - In the framework of cooperation with the University of Pristina-Department of Social Work, a project was presented that will be implemented in 2025 by Vives University of Applied Sciences from Belgium for

cooperation opportunities with staff training but also for internships by students of this university in the correctional institutions of the KCS.;

- With the NGO "SIT", after signing a cooperation agreement, in the Municipality of Lipjan the "Y+ Program" for minors starts, being held every second week with two groups of minors with educational measures and with prison sentences;
- Part of the working group within the Ministry of Justice regarding the "16 Days of Activism" campaign regarding issues of violence against women and domestic violence, but also actively participated in the campaign activities,
- Cooperation with the Emplyoment Agency of the Republic of Kosovo, regarding the implementation of professional training and the certification of candidates.
- Cooperation with the Ministry of Justice and the Council of Europe expert regarding the assistance and implementation of the Pilot Program for the Treatment of Perpetrators of Domestic Violence for 10 prisoners who also completed the 6-month program in CC-Dubrava.
- Cooperation with the Red Cross and the realization of requests for clothing for prisoners according to
 the needs in the Institutions and volunteers of the Kosovo Red Cross held a lecture with a group of
 female prisoners regarding personal hygiene and other issues related to women's health, after this
 lecture the two trainers and some women planted flowers sent by the RCK in the spaces of the
 Institution's yard as well as a lecture on health education on contagious diseases.
- · Two-day workshop by HELP Kosovo on the topic "Women in Business" for imprisoned women,
- Participation in meetings of the team for monitoring prisoners for terrorism-related offenses in Dubrava and HSP and CIU regarding their engagement in programs (work, school, training, other activities), information exchange, cooperation, upcoming releases, etc.
- Monitoring the development of professional training with prisoners in Correctional Institutions,
- Cooperation with the OSCE and holding three workshops/trainings for female prisoners on the topic
 of domestic violence and other similar topics. A donation of 60 different book titles in Albanian,
 English, German and Serbian was also made.
- Cooperation with the NGO "Woman for Woman" holding a lecture on the topic: Gender-based violence with imprisoned women;
- Through the NGO "SIT" in cooperation with the Department of Psychology, on the topic of mental health, two lectures were held in CC-Dubrava for adult prisoners and in CC-Lipjan for juveniles;
- In collaboration with several poets from the Republic of Albania and the Republic of Kosovo, a literary hour was held for imprisoned women and minors in two institutions in Lipjan, and a number of books were also distributed to both institutions by these poets.

EDUCATION

School year 2023/2024.

From April until the end of the 2023/24 school year, a minor from the Correctional Education Center attended school in the city of Lipjan.

The 2023/24 school year has been completed:

At the Lipjan Juvenile Correctional Center - sixteen (16) juveniles:

- · Lower secondary school grades I-V / one (1) juvenile;
- Lower secondary school grades VI-IX / six (6) juveniles;
- Higher secondary school grades X-XII / nëntë (9) juveniles.

In Dubrava Correctional Center - twenty-nine (29) convicts:

- · Grade X was completed by nine (9) convicts;
- Grade XI was completed by thirteen (13) convicts;
- Grade XII was completed by seven (7) convicts.

School year 2024/25:

Thirty-three (33) juveniles have started their studies at the Lipjan Juvenile Correctional Center, while forty-nine (49) convicts have started their studies at the Dubrava Correctional Center.

Salaries and Allowances:

Initial Budget for Salaries and Allowances: €13,757,714.74 with 1,770 approved positions.

Current Budget for Salaries and Allowances: €13,723,934.72 (According to Law No. 08/L-260 on Public Sector Salaries, which started to be implemented in February 2024).

Expenditures from January to December: €13,723,934.72, based on monthly allocations. Compared to the initial budget, salaries were spent at 99.75%, and compared to the current budget, they were spent at 100.00%.

Goods and Services

Initial Budget for Goods and Services: €6,056,737.90. Based on the Kosovo Correctional Service (KCS) requests, additional funds of €1,200,000.00 were allocated and transferred from the Capital Projects category of the KCS.

Current Budget for Goods and Services: €7,256,737.90. Expenditures from January to December: €7,000,810.71.Compared to the initial budget, goods and services were spent at 115.59%, and compared to the current budget, they were spent at 96.47%.

Municipal Expenses

Initial Budget for Municipal Expenses: €969,769.00. Expenditures from January to December: €947,052.26. Compared to the initial and current budgets, municipal expenses were spent at 97.66%.

Capital Expenditures

Initial Budget for Capital Projects: €8,005,000.00. Current Budget for Capital Projects: €2,645,000.00. Expenditures from January to December for Capital Projects: €2,008,567.61.

Compared to the initial budget, capital expenditures were spent at 25.09%, and compared to the current budget, they were spent at 75.94%.

VII. THE SEVENTH PART

Procurement

The Kosovo Correctional Service (KCS), with the aim of providing adequate conditions for the life of prisoners and ensuring the continuous supply of equipment, food, and necessary items for the functioning of correctional institutions, has planned and developed procurement procedures.

Based on the Public Procurement Law (PPL) and Regulation No. 001/2022 on Public Procurement, as well as the procurement plan, a total of 50 activities were planned to be carried out during the year 2024, as outlined below:

A total of 27 activities were planned in the procurement plan for supplies, 16 activities were planned for services, and 7 activities were planned for work.

A total of 57 activities were carried out, with 9 activities being carried out outside the procurement plan, and 5 activities are currently in progress.

In the procurement plan, there are eight (8) activities that were carried out by the Central Procurement Agency (CPA) based on the decision of the Government of the Republic of Kosovo No. 15/67, which approved the list of common items.

From the Central Procurement Agency (CPA), the following activities have been carried out, where we are part of these contracts:

VIII. THE EIGHTH PART

Human Resources

During the year 2024, the Human Resources Division, within its legal competencies, organized work and activities with the aim of achieving the general objectives of the Kosovo Correctional Service.

The Kosovo Correctional Service, according to the Budget Law for 2024, had 1,770 approved positions with a budget allocation of €13,757,714.74.

The budget allocated by the Budget Law has been spent at 99.75%.

The current number of staff in December 2024 in the Kosovo Correctional Service is 1,716.

Donations Received

The Kosovo Correctional Service received a donation from EULEX. During the official ceremony organized for this occasion, the handover agreement was signed with the Head of the EULEX Monitoring Pillar, Mr. Giovanni Galzignato, and the Head of the EULEX Correctional Unit, Ms. Anu Melkko.

Contribution of the EULEX Correctional Unit to the KCS for the year 2024

The EULEX Correctional Unit (CU) organized several working group meetings during which sub-legal acts were drafted/reviewed.

- Raising awareness in conducting K9 activities in prisons (in cooperation with the Finnish Prison Service).

- The CU participated in the KCS working group for assessing the needs of all correctional institutions and the working group for assessing needs for the donor conference.
- The CU monitored recruitment processes for various KCS staff groups (with a focus on senior management recruitment) and provided recommendations to KCS for improving the recruitment process.
- The CU continued to advise and support specific KCS units (the Prisoner Assessment and Classification Unit, K9
- The CU provided recommendations to KCS regarding amendments to Law No. 08/L-131 "On the Kosovo Correctional Service." The recommendations focused on the following areas: implementation of electronic monitoring, implementation of mandatory drug and alcohol testing in KCS institutions, and use of restraints and security equipment.

THE EULEX CORRECTIONAL UNIT HAS PREPARED AN INTERNAL STRATEGY/ MODULE FOR THE KCS.

- The CU provided written advice and recommendations to KCS regarding: the complete establishment of the Internal Training Center at the Dubrava Correctional Center for training KCS staff; determining suitable spaces for the placement of the KCS Central Archive; and the construction of an Operational Center for centralizing all security services in one location (including the Prisoner Escort Unit and the Weapons Depot).
- The CU organized a joint meeting between KCS and KPS, during which an agreement was reached for both services to use common tools for assessing the risks and needs of prisoners.
- The CU provided advice and recommendations to KCS working groups for the construction of new correctional centers (the new Prizren CC facility, the new Lipjan Correctional Training Center, and the expansion of the Kosovo Forensic Psychiatry Institute).
- The CU monitored various internal investigation processes within KCS regarding several incidents that occurred during the year.
- The CU provided recommendations to KCS regarding visitor control guidelines for the Mitrovica CC and High-Security Prison.
- The CU monitored the conditions of treatment for 54 prisoners (mostly from minority communities), helping KCS improve their treatment standards and refute unfounded allegations of mistreatment.
- The CU delivered the following donations to KCS: 1 vehicle, 293 IT equipment pieces (computers, handheld GPS, laptops, monitors, phones, printers, handheld radios, routers, scanners, shredders, switches); 3 pieces of facility equipment (generator, ladder, pallet lifter); 112 office furniture items (bookshelves, nightstands, tables, file cabinets, etc.). (These donations may be delivered by December 30th).

Support from the Council of Europe Office in Pristina during the year 2024

As part of the project "Improving the Treatment of Persons Deprived of Liberty," the Council of Europe has assisted the KCS in various ways. Although the KCS is not the direct beneficiary of the project, it has been included in the activities of the project in the same way as the direct beneficiaries and has benefited in several important areas, as outlined below.

Capacity Building – In 2024, the Council of Europe Office in Pristina organized a total of 10 two- and three-day training sessions, during which KCS staff were trained in key areas for the rehabilitation of prisoners. Additionally, several members were certified as trainers of trainers in occupational therapy, a new form of rehabilitative therapy being applied for the first time in Kosovo. This was a recommendation from the Council of Europe's Committee for the Prevention of Torture and the Office of the Ombudsperson and civil society. The certified trainers from KCS held six (6) cascade training sessions during the year, training over 100 correctional and healthcare officers, not only from KCS but also from HDP and IFP.

Furthermore, during 2024, KCS officers were trained in other important areas such as awareness-raising for psychosocial programs and rehabilitation methods, training on standard operating practices HDP, and raising awareness among technical and operational officers on the prevention and reporting of mistreatment in accordance with the Istanbul Protocol. A similar training was also organized for all prison directors.

<u>Document Drafting</u> – In addition to capacity building and the consolidation of the institutional memory of KCS, the Council of Europe has also assisted with the drafting of important documents, not only for KCS but also for the Ministry of Justice.

The Council of Europe has used an inclusive approach in its methodology and ensured that KCS was part of all working groups where documents impacting KCS operations were drafted, such as the development of guidelines for occupational therapy and standard operating practices for HDP and IFP. KCS officials contributed to the drafting of these documents. Additionally, an important document is the protocol and incident reports for the prevention of torture and ill-treatment according to the Istanbul Protocol, focusing on prisoners with mental health disorders.

Furthermore, the Council of Europe has assisted the Ministry of Justice in relation to its Action Plan for the Rule of Law Strategy 2024-2026, providing the necessary expertise to develop and submit a detailed analysis of the activity list (linked to KCS) in accordance with Council of Europe and international standards.

Received Donations:

- The Kosovo Correctional Service received the next donation from EULEX. In the official ceremony organized
 for this occasion, the Director General of KCS, Mr. Ismail Dibrani, together with the Head of the EULEX
 Monitoring Pillar, Mr. Giovanni Galzignato, and the Head of the EULEX Correctional Unit, Ms. Anu Melkko,
 signed the agreement for the receipt of this donation.
- The donation for KCS received from the EULEX Correctional Unit includes modern equipment such as: one
 (1) vehicle, one (1) generator, computers and laptops, as well as other technological equipment such as scanners,
 printers,
 phones,
 radios,
 and
 office
 inventory.
- An agreement has been signed for the acceptance of the donation provided by the United States of America through the INL program for the KCS Intelligence Unit, which includes various equipment such as: computer monitors, detection devices, and three (3) vehicles.
